Matter(s) investigated

Whether Lord Chadlington or The Chadlington Consultancy Limited conducted unregistered consultant lobbying

Registrar's decision

Based on information and assurances provided, Lord Chadlington has not conducted unregistered consultant lobbying either personally or through The Chadlington Consultancy Limited in relation to the matter under investigation.

Summary of rationale for decision

Based on substantive and unequivocal written information provided, Lord Chadlington made an otherwise registrable communication for which the incidental exemption applies.

Under the Transparency of Lobbying, Non-Party Campaigning and Trade Union Administration Act 2014 ("the Act"), a registrable communication is made by a VAT registered company or individual communicating with a Minister, Permanent Secretary (or equivalent) on behalf of a paying client.

Under the Act there is an incidental exception and my <u>guidance</u> sets out how I apply this narrow exception. Based on the information and assurances provided, the communication was not a substantive part of the main business assessed either:

- by volume; or
- by the value of the work undertaken; or
- by its significance to the client offering; or
- by the significance of its contribution to the business's non-lobbying activities.
